Manuel A. Castillo met this day with the Board requesting consideration of a onetime investment to assist the newly formed Viet Nam Veterans Counseling Center in the amount of \$20,000.00. Following the discussion the Board informed Mr. Castillo that Sweetwater County would not be able to give him the funds as the present budget is already set but would write a letter of support so that he could apply for a Community Development Block Grant.

Lee Harms, Dan Bennett, and Eugene Smith representing the Farson-Eden Fire District came before the Board seeking a firm commitment from them regarding additional equipment needed to enable them to utilize a paging system which had already been purchased. Mr. Bennett stated that they had been working with the Sheriff's office for over three years in an attempt to purchase the necessary equipment. Undersheriff Larry Paine told the group that to purchase the equipment now was a waste of money since in a year when the E911 System is to be in place, their equipment would not be needed. He also stated that new dispatch center equipment was needed for the E911 System which he estimated will cost approximately \$123,000.00. The Board told the Fire District representatives that should it not be feasible to purchase the new dispatch center equipment in the next budget year, the Fire District needed equipment would be purchased for them.

Thereupon, after the conduct of other business not pertinent to the following, the Chairman stated that the Board had received from PacifiCorp (the "Company") a notice that requests Sweetwater County, Wyoming to (i) remove Ehrlich Bober & Co., Inc. (Ehrlich") as Remarketing Agent and Issuer's designee for establishing rates pursuant to that certain Indenture of Trust (the "Indenture"), dated as December 1, 1984, between Sweetwater County, Wyoming, as issuer (the "Issuer"), and Irving Trust Company, as trustee, whose successor by merger is The Bank of New York, securing the \$15,000,000 Pollution Control Revenue Bonds (PacifiCorp Project) Series 1984 of the Issuer (the "Bonds") and (ii) appoint First Chicago Capital Markets, Inc. ("First Chicago") as successor Remarketing Agent and Issuer's designee under the Indenture to establish interest rates for the Bonds. Therefore, the Chairman explained, one purpose of the meeting was to consider and adopt a resolution (i) authorizing and ratifying the removal of Ehrlich as Remarketing Agent and Issuer's designee under the Indenture for establishing interest rates for the Bonds, (ii) authorizing and ratifying the appointment of First Chicago as successor Remarketing Agent and Issuer's designee under the Indenture for establishing interest rates for the Bonds and (iii) authorizing and ratifying the execution and delivery of a Notice of Removal of Remarketing Agent and Appointment of Successor related to the removal of Ehrlich and Appointment of First Chicago.

WHEREAS, Sweetwater County, Wyoming (the "Issuer") has heretofore issued its \$15,000,000 Pollution Control Revenue Bonds (PacifiCorp Project) Series 1984 (the "Bonds"); and

WHEREAS, in connection with the issuance of the Bonds, the Issuer has entered into a certain Indenture of Trust (the "Indenture"), dated as of December 1, 1984, by and between the Issuer and Irving Trust Company, as trustee, who has since been merged with and succeeded as trustee by The Bank of New York (the "Trustee"); and

WHEREAS, Ehrlich Bober & Co., Inc. ("Ehrlich") has heretofore been appointed pursuant to Section 9.10 of the Indenture as a successor Remarketing Agent and Issuer's designee (as both are described and defined in the Indenture) for establishing interest rates for the Bonds (collectively, the "Issuer's Designee"); and

WHEREAS, pursuant to Section 9.10 of the Indenture, the Issuer is authorized at any time to remove, with the consent of PacifiCorp (the "Company"), the Issuer's Designee and appoint a successor by giving notice thereof to the Trustee, the Remarketing Agent and the Bank (as defined in the Indenture); and

WHEREAS, the Issuer has received written notice from the Company directing and requesting the Issuer to remove Ehrlich as Issuer's Designee and to appoint First Chicago Capital Markets, Inc. ("First Chicago") as Ehrlich's successor thereto, pursuant to the provision of Section 9.10 of the Indenture; and

WHEREAS, the Chairman of the Board of County Commissioners of the Issuer (the "Board") has executed a Notice of Removal of Remarketing Agent and Appointment of Successor, in the form attached hereto as Exhibit A (The "Notice of Removal"), to serve as the written notice by which to effect the removal of Ehrlich and the appointment of First Chicago and has Pursuant to Section 9.10 and 12.01 of the Indenture, delivered the Notice of Removal to Ehrlich, as Remarketing Agent under the Indenture, the Sumitomo Bank, Limited, as Bank under the Indenture, the Trustee and First Chicago; and

WHEREAS, the Board deems it necessary and advisable to comply with the Company's direction and request for the removal of Ehrlich as Issuer's Designee and the appointment of First Chicago as Ehrlich's successor thereto; and

WHEREAS, it is necessary to authorize and ratify the execution and delivery, by and on behalf of the Issuer, of the Notice of Removal;

NOW, THEREFORE, Be It Resolved by the Board of County Commissioners of Sweetwater County, Wyoming, as follows:

Section 1. The Board accepts the notice received from the Company requesting that Ehrlich be removed as Issuer's Designee and directing and requesting the First Chicago be appointed as Ehrlich's successor thereto.

Section 2. Pursuant to the Company's direction and request and the execution and delivery of the Notice of Removal, Ehrlich shall be and is removed as Issuer's Designee, and First Chicago shall be and is appointed as Ehrlich's successor thereto. The Notice of Removal executed by the Chairman of the Board and delivered to Ehrlich, the Trustee, The Sumitomo Bank, Limited and First Chicago shall serve as the written notice by which the removal and appointment shall be effected, and the Board hereby authorized and ratified the execution of the Notice of Removal by the Chairman of the Board on behalf of the Issuer.

Section 3. The removal of Ehrlich as Issuer's Designee and the appointment of First Chicago as Ehrlich's successor thereto shall be effective upon written acceptance by First Chicago of its appointment and the duties and obligation under the Indenture and receipt by the Trustee of the acceptance, as provided in Section 9.10 of the Indenture.

Section 4. This Resolution and the entire proceedings had in its adoption shall forthwith be published in the Rock Springs Daily Rocket-Miner, a newspaper of general circulation in the County.

Section 5. The provision of this resolution are hereby declared to be separable and if any section, phrase or provision shall for any reason be declared to be invalid, such declaration shall not affect the validity of the remainder of the sections, phrases and provisions.

Section 6. All resolutions and parts thereof heretofore enacted by the Board in conflict herewith are hereby repealed to the extent of such conflict.

Section 7. Immediately after its adoption, this resolution shall be signed by the Chairman and attested by the County Clerk, shall be recorded in a book kept for that purpose and shall take immediate effect.
