County officials and various department heads met with the Board to discuss their views regarding employee salary increases for the 1991-92 fiscal year. A number of employees have accumulated more vacation time than is allowed under the County Personnel Policy. It was determined that a "take it or lose it" policy begin effective September 1, 1991, and that employees be encouraged to reduce their vacation accumulation to the maximum or less, or lose the overage at that time. From September first forward, the computer will not allow for accumulation above the maximum allowed.

At this time the Chairman called for an executive session to discuss personnel matters with Bob Gordon, County Planning Director.

Following the executive session, the Chairman re-convened the meeting of the Board.

An appeal by Rex Petersen was heard regarding the Planning and Zoning Commission's action to deny his Home Occupation Type III Permit to allow the sale of hay and feed on his property being Lot 4, Block 6 in the El Rancho 1st Subdivision. Objections by adjacent property owners Ed Thomas and Sylvia Aldred was the primary reason for denial. A formal hearing was conducted with Mr. Petersen's spokesperson, Ann Petersen, Nena James, Attorney at Law, representing

the Planning and Zoning Commission and Clifford Boevers, Deputy County Attorney, providing assistance to the Board. A full and complete recording of the hearing is on file within the County Clerk's office. Following testimony by those concerned, Mr. Boevers suggested the Board take the matter under advisement until May 15th for a proper findings of fact. Larry Caller moved that the hearing be closed, Linda M. Taliaferro seconded and the motion carried.

A public hearing for an Exception Renewal for Richard Vasa, being the E/2 of Lot 28 in the Mountaineer 4th Subdivision, Sweetwater County, Wyoming, was held. Linda M. Taliaferro moved to approve the Exception as presented. Larry Caller seconded and the motion carried.

A public hearing for a subdivision variance requested by Stan Ackerman, being five lots located in the SW/4 of the NE/4 of Section 9, Township 19 North, Range 105 West, Sweetwater County, Wyoming, was held. Linda M. Taliaferro moved to accept the recommendation of the Planning and Zoning Commission and grant the variance as requested. Larry Caller seconded and the motion carried.

A public hearing on Oil and Gas Development pertaining to the closure of oil and gas leasing on Federal lands around the cities of Rock Springs and Green River as held. Comments made during the hearing came for Don Judas of the BLM, and Leonard Hay and Steve Horton, presenting a letter from Mayor O'Block of Rock Springs, George Eckman, Mayor of Green River, Tom Spicer of the Planning and Zoning Commission and David Bowers of the Petroleum Association. A full and complete recording of comments made is on file within the County Clerk's office. Following the comments, Commissioner Linda M. Taliaferro stated that she wished to abstain from the vote because it adversely affected her as a property owner. The Chairman again read the recommendation that to the extent allowable under Wyoming Statute Section 18-5-201 or any other pertinent Wyoming Statute that the current BLM oil and gas leasing policy on Federal lands around the Rural Population Center remain case-by-case as it currently is and have Federal oil and gas leasing within the Green River/Rock Springs area as outlined on the attached map be on a case-by-case basis. A motion was duly made by Larry Caller seconded by Fred Radosevich and carried that the recommendation by the Planning and Zoning Commission be upheld and remain on a case-by-case basis.

It was moved by Larry Caller, seconded by Linda M. Taliaferro and carried that Resolution 91-05-08-02 passed earlier this day regarding the closure of the "CCC" Bridge during construction, be held until additional information could be obtained.

There being no further business to come before the Board, the meeting was adjourned, subject to the call of it's Chairman.
