1. SITE PLAN

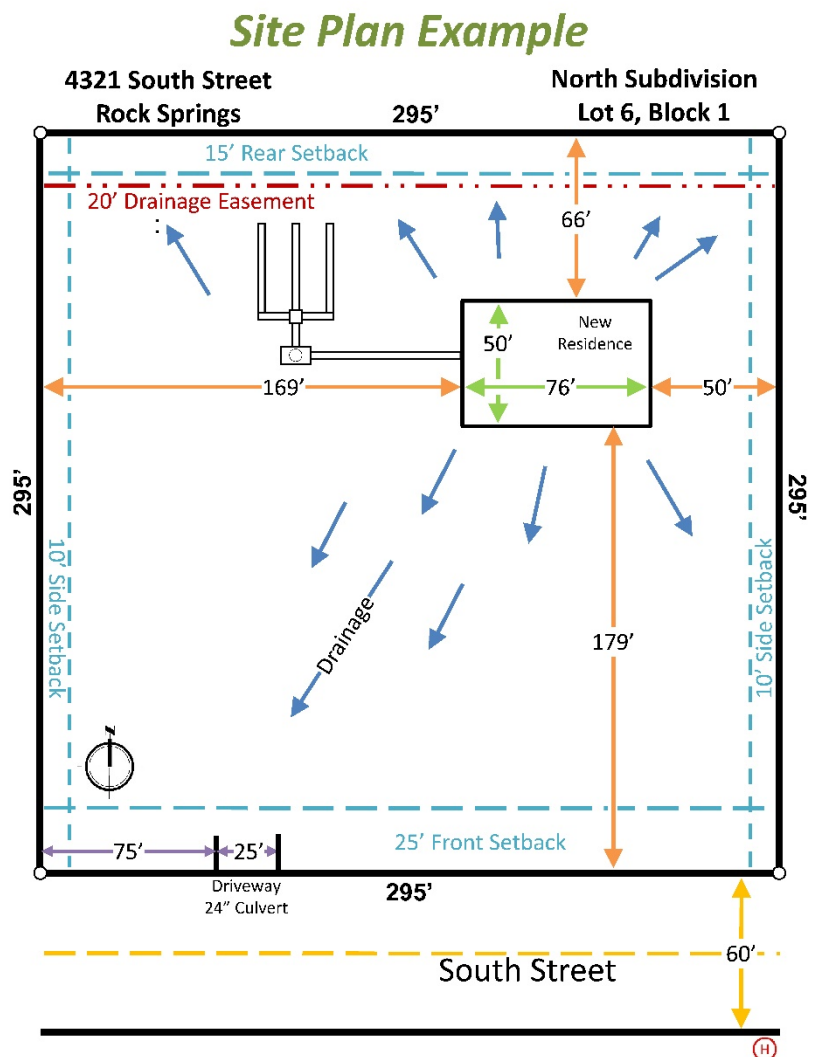
A site plan, legibly drawn to scale and based on legally established lot corners that are permanently marked and identified, showing the following information:

Residential Site Plan Requirements

- Address of the property
- Legal description (subdivision, lot, block)
- Property dimensions
- Setbacks and dimensions of existing structures
- Setbacks and dimension of proposed structures
- Location of fire hydrants
- Driveway location, width, setback & culvert size
- Arrows showing drainage direction & easements
- Septic and well locations
- Fuel tanks being used or stored
- Utility locations and easements
- Residential floor plan including:
 - Rooms labeled and dimensioned
 - Size of egress windows and doors
 - Location of smoke detectors & CO detectors
 - Type of door hardware
 - Hallway widths and width of stairs
 - Separation material for attached structures

Non-Residential Site Plan Requirements

- Items a through k above **PLUS**
- Parking and loading areas
- Commercial signage
- Outdoor storage areas
- Type of outdoor lighting & placement
- Commercial floor plan including:
 - Rooms labeled and dimensioned
 - Site of egress windows and doors
 - Location of smoke alarms
 - Type of door hardware
 - Hallway widths and width of stairs
 - Fire separation materials
 - Location and type of exit signs
 - Details of emergency lighting plan
 - Location of fire extinguishers



SIGNATURE REQUIRED

Lot and parcel development standards may be found in Sections 4 & 5 of the Zoning Resolution. Sweetwater County has adopted and will inspect for the 2015 International Fire Code. Sweetwater County **has not adopted and does not enforce** the International Residential Code or the International Building Code. It is the applicant's or landowner's responsibility to ensure that construction standards are met and buildings and structures are inspected.
