- Request ballot from the County Clerk's office for the Primary and General Election.
- No reason required.
- The ballot must be received in the County Clerk's office before 7:00 p.m. on Election Day.
- Avoid the lines.
- No need to worry about forgetting or having the time to vote on Election Day.
- Your vote will count.
